2. 檢附資料：(1) 鑑定意見書影本。(2) 申請人需為當事人或其繼承人或法定代理人、車輛所有人，填具申請表並檢附身分證影本或行車執照影本。  
Submitted documents: (1) **Copy of the opinion letter**. (2) The applicant shall be the litigant, his/ her heir or statutory agent or the registered owner of the vehicle; **please fill in the application form and submit a photocopy of his/her national ID or driver's license**.
3. 當事人如為身心障礙及低收入戶者，自 109 年 5 月 14 日至 110 年 5 月 13 日止，以申辦收案日期為準，可辦理減半徵收覆議規費，請備妥有效期限內之證明文件影本及一千元郵政匯票一紙。  
From May 14th, 2020 to May 13th, 2021, disabled or low-income households could have half-fees when applying reconsideration. Identity is based on the date of submission. Submitted documents: (1) **Copy of the valid certification**. (2) **A postal order of NT\$1000**.
4. 申請案件可郵寄(信封請註明覆議申請)或親自到會辦理，須於一個月內提出(郵寄者以郵戳為憑)，逾期不受理。  
The application can be submitted by regular mail (please label it as a reconsideration application on the envelope) or delivered to our office in person; the application must be made within one month (postal submission will be judged by postmarks), Overdue applications will not be accepted.
5. 案件已進入司法程序者不予受理，應向司法機關聲請轉送臺南市車輛行車事故鑑定覆議委員會覆議。  
The case will not be accepted if it is under judicial procedure; the applicant shall apply to the judiciary for transferring the case to the Tainan Traffic Accident Investigation Reconsideration Committee for reconsideration.
6. 因和解或其他理由自行撤回者無法退費，請仔細考慮後再申請。  
A withdrawal due to the settlement or other reasons cannot be refunded; please apply after a thorough consideration.

The reconsideration opinions are only reference for the litigant and the judiciary for the proceedings of cases. They are limited to one time only, and shall be documentary reviews in principle. We will not ask the litigant to travel to the office for further explanation.
